



# **Understanding your audience North Carolina**



- There are OVER A MILLION Hispanics in NC
- 9.8% of NC population is Hispanic or Latino
- 61% of NC population is U.S-Born
  - 54% identify as Mexican ancestry
- 77% Speaks other language than English at home
- 75% Adults with no post-secondary degree
- 61% hold high school degree or less
- Most likely report intentions to post secondary education via the NCCCS
- 1 in 4 Hispanics live in Mecklenburg or Wake County
- Rural Carolina fastest growing:
  - In Duplin County, for example, 23% of residents are Hispanic; Sampson (20%), Lee (20%), Greene (16%), and Montgomery (15%)

### **Documented Vs. Undocumented**



#### DOCUMENTED

- U.S. citizens or nationals
- U.S. permanent residents (hold permanent resident cards I-551, I-151, or I-551c)
- Eligible non-citizens, who have been given an I-94 (Arrival-Departure Record) by the Department of Homeland Security:
  - Persons granted asylum and refugees
  - Persons paroled into the U.S. for at least one year
  - Battered immigrants, qualified aliens and their designated children
  - Conditional entrants, Cuban-Haitian entrants, or victims of human trafficking awarded a T-Visa

#### UNDOCUMENTED

- Entered the U.S. without inspection or with fraudulent documents; or
- Entered legally but then violated the terms of status and remained in the country without authorization.

# Challenges



- Understanding processes
  - (College applications, RDS, and FAFSA)
- Paying for college
  - Ineligible for State and Federal Financial aid
  - Out of state for tuition and admissions purposes
  - Even if qualify, process can be daunting
- Misinformation/Fear of disclosure
- Out of state for tuition and admissions purposes
- Federal, state, and local policies
- Limitations in obtaining licensure
- Lack of mentorship/sponsors/trusted influencers within their communities
- Representation within institutions (faculty and staff)
- Cultural clashes and disparities

# First Generation College Students...and...



Students who are the first person in their immediate family to attend college - i.e. neither of their parents have a college degree

Most immigrant students or children of immigrant parents are first generation college students.

- 61% parents with high school or less
- 75% Adults without post-secondary degree
- Limited English Ability



# DACA (Deferred Action for Childhood Arrivals)



- Enacted in June 15, 2012 as an Executive Action under President Obama, this immigration
  policy has been rescinded by the Trump administration AND on June 18<sup>th</sup> 2020 ruled as
  unlawful to dismantle DACA
- Protected status from deportation and eligible for a work authorization
- New applications and renewals are currently being accepted \$495 every 2 years
- Not a path for citizenship
- In NC students with DACA don't qualify for state or federal financial aid
- Considered out-of-state students for tuition and admission purposes

## **Temporary Protected Status (TPS)**



- Humanitarian aid that does not lead to citizenship
- The Secretary of Homeland Security may designate a country for TPS due to the following:
  - Ongoing armed conflict (such as civil war)
  - An environmental disaster (such as earthquake or hurricane), or an epidemic
  - Other extraordinary and temporary conditions
- During a designated period, individuals who are TPS beneficiaries
  - Are not removable from the United States
  - Can obtain an employment authorization document (EAD)
  - May be granted travel authorization
- Countries currently designated for TPS
  - El Salvador, Haiti, Honduras, Nepal, Nicaragua, Somalia, Sudan, South Sudan, Syria,
     Yemen, and Venezuela
- Eligible for in-state tuition but not eligible for federal and state financial aid

## Mixed Status families



- Families that do not share the same citizenship or immigration status
- Complete FAFSA with some recommendations
- Many families rely on the support of their children
- Difficulties navigating processes

# **NC Community College Admission Policy**



Each college shall maintain an **open-door** admission policy to all applicants who are legal residents of the United States and who are either high school graduates or are at least 18 years of age....

- For the purposes of this Section, "undocumented immigrant" means any immigrant who is not lawfully present in the United States. Community colleges shall admit undocumented immigrants under the following conditions:
  - Community colleges shall admit an undocumented immigrant only if he or she attended and graduated from a US public high school, private high school, or home school that operates in compliance with State or local law;
- When considering whether to admit an undocumented immigrant into a specific program of study, community colleges shall take into account that federal law prohibits states from granting professional licenses to undocumented immigrants;
   And
- Students lawfully present in the United States shall have priority over any undocumented immigrant in any class or program of student when capacity limitations exist.

# Admissions to Colleges: Rules to Students with DACA classification



### Memorandum - August 1, 2013

Since individuals with DACA classification are lawfully present during their period of deferral and do not fit the definition of an undocumented immigrant per 1D SBCCC 400.2(b), community colleges should treat an individual with DACA classification like any other student who is lawfully present in the United States with two exceptions:

- Local community colleges have the discretion to determine whether to admit an individual with DACA classification into a specific program of study leading to professional licensure.
- Individuals with DACA classification do not have the capacity to receive in-state tuition.

## **Professional Licensures – What to know**



- Some colleges deny admission to programs/courses based upon the licensing requirements
- There is no comprehensive list of courses/programs leading to licensure and those licensure requirements
- Licensing agency (e.g., nursing board) sets the requirements not the colleges.
- It is important that colleges ensure that all participating students be eligible for credential and set enrollment criteria accordingly.

# Students attending four-year institutions



### Each institution provides their own guidelines:

- Can attend, but cannot receive federal or state funding in NC
- Must meet minimum admission requirements
- For admissions purposes may be considered out-of-state
- May be considered international students
  - Follow deadline for international students
  - May handle financial aid different
- Merit scholarships may be available automatically or by an additional application

# **Residency Determination Service (RDS)**



- •RDS is a uniform process for determining NC residency used for in-state tuition and NC grant eligibility. Students do one residency determination for all NC Colleges and Universities.
- •By law, residency for tuition and grant purposes is based on the student's parent/legal guardian unless the student can prove otherwise. Online interview will ask about parents similar to FASFA.
- •DACA and undocumented students are NOT eligible for in-state tuition and state financial aid.
- •Students with undocumented parents completing RDS can include parents ITIN number. DO NOT ENTER ALL ZEROS.

All zeros for parent social security number



# Students with Parents Without a Social Security Number



- If the student is eligible to complete the FAFSA, the status of the parents does not matter
- If parents do not have a social security number, enter 000 00 0000
- Student may receive error message, click on continue to proceed with application
- Parent will not be able to use the DRT
- Do not use ITIN Number
- Print signature page for parent,
- Send signature page to appropriate address
- Submit the FAFSA



# **Tuition Classification Exemptions at NC Community Colleges**



- Business-Sponsored Students
- Business & Military –Transferred Families
- \*Non-Profit Tuition Sponsorship
- \*Public School Graduates
- Refugee
- Non-Resident of the US ("Pending Permanent Resident")
- Federal Law Enforcement Officers

### \*DACA not eligible

# **Tuition Classification Exemptions at NC Community Colleges**



Note: These exceptions permit campuses to override students' tuition status and charge in-state tuition to students classified as non-residents per RDS. Because some exceptions are available based upon campus-specific conditions, such as enrollment, RDS cannot provide final answers with respect to eligibility since RDS does not have insight into those campus-specific factors.

Exceptions are outside of RDS and must be approved by someone at the college to give student in-state charges –but their residency status will remain what was assigned by RDS.

## **Non-Profit Sponsored Tuition**



The North Carolina General Statute 115D-39 (c)states:

"... a person sponsored under this subsection who is **lawfully admitted to the United States** is eligible for the State resident community college tuition rate. For purposes of this subsection, a North Carolina(NC) nonprofit entity is a charitable or religious corporation as defined in G.S. 55A-1-40 that is incorporated in NC and that is exempt from taxation under section 501(c)(3) of the Internal Revenue Code, or a civic league incorporated in NC under Chapter 55A of the General Statutes that is exempt from taxation under section 501(c)(4) of the Internal Revenue Code. A nonresident of the United States is sponsored by a NC nonprofit entity if the student resides in NC while attending the community college and the NC nonprofit entity provides a signed affidavit to the community college verifying that the entity accepts financial responsibility for the student's tuition and any other required educational fees. Any NC nonprofit entity that sponsors a nonresident of the United States under this subsection may sponsor no more than five nonresident students annually under this subsection. This subsection does not make a person a resident of NC for any other purpose."

Each institution should develop their own Requirements

# **Business sponsor exception**



Pursuant to N.C.G.S § 115D-39(a), "when an employer other than the Armed Forces . . pays tuition for an employee to attend [a community college] and . . . the employee works at a North Carolina business location, the employer shall be charged the in-state tuition rate." If a student is employed at a North Carolina business location and the employer of the student working at the North Carolina business location wants to pay for the student to attend a community college, the employer shall be charged the in-state tuition rate.

Each institution develops their own requirements. Know the requirements for your institution!

## NC Public School Graduates



Any person **lawfully admitted** to the United States who satisfied the qualifications for assignment to a public school under North Carolina law (G.S. 115C-366) and graduated from the public school to which the student was assigned **shall be eligible for the State resident community college tuition rate**. This provision does not make a person a resident of North Carolina for any other purpose.

\*DACA/Undocumented no eligible for this exception

# Refugee Tuition Exception



A refugee who lawfully entered the United States and who is living in this State shall be deemed to qualify as a domiciliary of this State under G.S. 116-143.1(a)(1) and as a State resident for community college tuition purposes. While the refugee must live in North Carolina to be eligible for in-state tuition, the refugee is not required to be domiciled in North Carolina for the 12-month qualifying period.

Applicants should present official refugee documents for this exception

### Non-Resident of the United States



A non-resident of the United States who has resided in North Carolina for a 12-month (365 days) qualifying period and has filed an immigrant petition (Forms I-130, I-360, or I-140) with the United States Citizen and Immigration Service (USCIS) shall be considered a North Carolina resident for community college tuition purposes.52

# Reminders

- DACA and Undocumented students are not elegible for state and federal aid
- Many universities offer financial assistance to DACA/Undocumented students
  - Who is your contact person?
  - What are your processes?
  - Is this clearly communicated on your website?
- May qualify for institutional, local, state, and national scholarships
- They can complete FAFSA (DACA) online or paper (undocumented) if the school requires it
- Sponsorships, fellowships, and assistantships
- Obtaining college credits in High School (CCP, AP, and CLEP)
- Think about NC Promise schools
- College savings plan such as NC 529
- Others?


