FSA Programs provide financial assistance for postsecondary students.



FSA Programs are authorized under Title IV of the Higher Education Act of 1965 as amended.



FSA refers to both the aid programs and the Department of Education Office administering them.



Congress determines aid programs and funding levels.







# Eligibility & Certification Approval Record (ECAR)


- Contains school details approved by Department of Education (DOE)




